3. Each piece of equipment to be considered for trade-up payment must have a trade-up form. All form fields must be completed, and a photo of the unit and serial tag is to be submitted with the form. Loyalty rebates submitted without all requested information shall result in the additional \$250 rebate being forfeited from rebate total.
4. Winston Foodservice (FS) Sales Administration reserves the right to reject trade-up applications. The sales representative will be notified immediately when rejections are determined.
5. Duplicate trade-up claims will be rejected, and Winston FS reserves the right to disapprove rebate applications.
6. This offer may not be used in conjunction with any other special promotion or pricing and the trade-in unit must be like the new model being purchased (holding for holding or a cooking unit for a retherm oven or cook & hold).  
\*Winston model stacked pair rebate not to exceed \$1,250 and competitor stacked pair rebate not to exceed \$1,000.
7. The completed trade-up forms must be submitted within 90 days of invoice date. Forms received beyond 90 days will be rejected.
